- Quotation Validity: your offer must remain 30 days from the date of submission of the quotation before which a contract/ purchase order if awarded should be accepted by you.

Payment

Payment will be made within 14 days of satisfactory delivery of services and documents in good order via bank transfer at the bank account of the company. No advance payment will or can be made. Please specify your payment terms if different. Maldivian Red Crescent is exempted from payment of all types of taxes. For the service procurement, the service provider needs to clear all its government tax obligations under this contract and the MRC will not be responsible. The service provider may be requested by the MRC to provide tax payment proof.
