Production of First Aid Kit Bags

Background

The Maldivian Red Crescent is an independent, voluntary, humanitarian organization, established on the basis of the Maldivian Red Crescent Law [Law 7/2009]. Its primary objective is to provide humanitarian aid, and to prevent and alleviate human suffering. It is the 187th member of the world's largest humanitarian movement — the International Red Cross and Red Crescent Movement — which every year helps millions of people whose lives have been devastated by crises or conflict.

Purpose

- Maldivian Red Crescent is seeking a service provider for the production of 100 First Aid Kit Bags. The details of the product are as follows:
- 1. Material: 1680D PVC with thick foam padding (can be changed to a more waterproof material)
- 2. Dimensions: H 47cm, L 27cm, W 17cm
- 3. Inside: 7 detachable pouches with Velcro
- 4. Top and side handles so the kit can be carried in either orientation
- 5. Backpack style shoulder straps

Evaluation of Quotations

Quotations will be evaluated based on value for money, quality and delivery timeline.

- All offers should be submitted on the company letterhead and duly stamped and signed.
- Price should be quoted in Maldivian Rufiyaa currency and must include shipping charges and per piece price.
- Quotation Validity: your offer must remain 30 days from the date of submission of the quotation before which a contract/ purchase order if awarded should be accepted by you.

Payment

Payment will be made within 14 days of satisfactory delivery of goods via bank transfer to the service provider's company account. No advance payment will be made. Please specify your payment terms if they differ. Maldivian Red Crescent is exempt from the payment of all types of taxes. The service provider is responsible for clearing all its government tax obligations under this contract. The MRC will not be held responsible for tax matters and may request proof of tax payment from the service provider.
